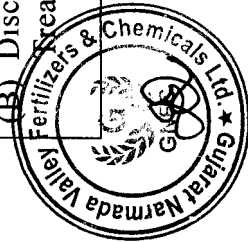

(A) Composition of Board	49(IA)	Yes	The Board of Directors of the company presently comprises 8 Directors, of which, 7 Directors are the Non-Executive Directors (NEDs), representing 87% of the total strength. Chairman of the company is a NED and has been nominated by Government of Gujarat as one of the promoters of the company. All NEDs on the Board are Independent Directors (IDs). The composition of the Board is in conformity with this clause.
(B) Non-executive Directors' compensation & disclosures	49 (IB)	Yes	NEDs of the company are paid remuneration by way of Sitting Fees only, for attending the meetings of the Board and / or Committees thereof. Sitting Fees paid to NEDs are within the limits prescribed under the Companies Act, 1956. Hence, approval of shareholders is not required. In case of Directors, who are from Indian Administrative Service, Sitting Fees payable to them for attending the meeting(s), is deposited with Government Treasury.
(C) Other provisions as to Board and Committees	49 (IC)	Yes	Three Board Meetings have been held sofar during the financial year 2013-14 with a time gap of not more than four months between any two meetings. The information as required under this clause were made available to the Board of Directors. None of the Directors holds membership in more than 10 committees or acts as Chairman of more than 5 committees across all companies in which he is a Director. The Board of Directors periodically reviews the Compliance Report of Laws applicable to the company.

All the Members of Audit Committee are financially literate. Dr. Ashok Shah and Dr. Rajiv Kumar Gupta, IAS, who are the Members of Audit Committee, remained present at the last Annual General Meeting (AGM) held on 21.9.2013 as Shri DC Anjaria, Chairman of the Audit Committee, who was retiring by rotation at the said AGM, has chosen to abstain from attending the AGM. Representatives of Internal Auditors and Statutory Auditors attend the Audit Committee Meeting by invitation. Chief Financial Officer of the company attends the Audit Committee Meeting. The Company Secretary acts as a Secretary to the Committee. Two Audit Committee Meetings have been held so far during FY 2013-14. The gap between two meetings did not exceed four months. Requisite quorum was present at the said meetings. The terms of reference of Audit Committee include the matters referred to in Clauses 49 II (C), (D) and Section 292A of the Companies Act, 1956. The relevant information as referred to in this sub-clause is submitted to the Audit Committee for its review on an on-going basis. The company does not have any subsidiary company.
